# Are you retiring soon?



Here is some important information to know.

For many people, the years just prior to retirement can be a reality check. They discover that they may face a gap between the retirement income they want and the actual income they can expect. If you find yourself in this situation, try not to panic. The 457(b) Horizons and 401(k) Savings Plans offer some additional ways to increase your savings up to your retirement:

- Age 50+ catch-up contributions—In the year you reach age 50, the Internal Revenue Service
  (IRS) raises the limit on how much you can contribute to your account each year (known as the
  age 50+ catch-up contribution). If you qualify, you can contribute an additional \$7,500 in 2024.
- Three-year catch-up contributions—If you are within three calendar years of normal retirement age, as defined by the Plan, you may be able to contribute even more—up to \$46,000 in 2024—with the three-year catch-up provision. Please note: you cannot take advantage of both types of catch-up contributions in the same calendar year. Three-year catch-up contributions are only available in the 457(b) Horizons Plan.
  - Application deadline: most participants apply for three-year catch-up contributions at least 4-6 months in advance of the desired start date. To apply, contact the Pasadena local office at (800) 947-0845.
- Contributing your termination pay—Your final paycheck from the County can boost your
  retirement savings. You can contribute the payout of any unused vacation, sick leave, and holiday
  pay to your account, up to the annual limit.
- Application deadline: most participants apply for termination pay deferral 90 days in advance
  of the desired retirement date. To apply, contact the Pasadena local office at (800) 947-0845.
   The termination pay form must be received and in good working order in the Pasadena office
  at least 40 days in advance of the retirement date.

And once you retire, here are some great reasons for you to stay in the plan!

- Affordable: The 457(b) Horizons and 401(k) Savings Plan offer low administrative costs. Also, investment products are institutionally priced and may be more competitive than retail mutual funds.
- Flexible Distribution Options: When it's time to start withdrawing your money, you can take
  unlimited partial distributions anytime or periodic distributions on a monthly, quarterly, semiannual, or annual frequency. You can cancel withdrawals and stop payments when needed. You
  can also choose to purchase an annuity and receive payments from an annuity provider.
- Convenience: After retirement, access to retirement guidance continues and you maintain
  control over your account. Required minimum distributions (RMDs) begin in the year you
  turn 73 or by April 1 of the following year. You are not required to take the RMD while actively
  employed with the County.
- Professionally Managed Investments: By staying in the Plan(s), you maintain access to the target date funds and various asset class funds available in the plans. More knowledgeable investors who acknowledge and understand the risks associated with the investments can select their own investments through a self-directed brokerage account option.

#### **Ask a Business Agent**

What happens if I am required to have a driver's license but can no longer drive due to temporary physical or legal limitations?

First, like most situations where you feel there may be trouble at work, you should call CAPE to discuss the status of your situation.

After we've discussed the situation and possible scenarios, you should contact your HR Risk Management Section to request an Interactive Process Meeting (IPM). When a member needs accommodation, their department assesses the operational feasibility of making such accommodations after the member participates in an Interactive Process Meeting. (Remember, in order to access CAPE representation for an Interactive Process Meeting, you need to contact the CAPE office and request to speak to a Business Agent upon learning that accommodations at work will be necessary.)

Depending on the situation, you may need an attorney to assist in tailoring driving restrictions that allow some driving tha does not violate court orders. Restrictions might include driving only to and from work, installation of a court-approved Ignition Interlocking Device (IID) on your vehicle that will disable the vehicle if alcohol is detected when trying to start your vehicle, etc. Your attorney will work with the court for options and these restrictions will likely include where and when you can drive.

If you have a medical condition that is the cause of your driving limitation, medical documentation in support of an accommodation request will be required as part of the IPM.

Remember, though possession of a current driver's license may be a requirement of your present job, working with your CAPE Business Agent, assignments or positions may be found that do not require you to drive as an essential function, be it reassignment to a comparable position or, if necessary, working from home, or a temporary assignment at a lower Classification level. This will help you to maintain your County Employment, healthcare, retirement, and all the other benefits that union membership brings to you and your family.

# **Preserving worker** longevity through office ergonomics

CAPE represents nearly 3,000 employees, many of whom gruel over a computer workstation as a regular part of their job. Computer use can expose us to various ergonomic risk factors such as repetition, contact stress, and awkward or static postures. Exposure to more than one risk factor increases the chances of experiencing discomfort. The risk factors also have a cumulative effect over time that increases our risk of injury or, more specifically, a musculoskeletal disorder (MSD).

MSDs are soft tissue injuries that can occur anywhere in the body and typically are not caused by a single traumatic event but rather are due to repetitive microtrauma to tissues that have not had the opportunity to heal (a hint to the importance of taking our breaks and allowing our body to rest). Pain and discomfort are often an indication of a developing MSD. Common MSDs include the trigger finger, carpel tunnel, and tennis elbow, among others. The Bureau of Labor Statistics reports there are tens of thousands of injuries to office workers each year.

MSDs can be controlled through ergonomics or working in postures that result in the least and minimal demands on the body, although working in neutral postures is not entirely intuitive. Much like anything else, learning to preserve neutral postures in front of a computer takes some training and practice, but it is worth it! The energy otherwise lost to our exposure to the ergonomic risk factors can be preserved and used for the more important things in our lives like caring for loved ones, time outdoors, or just living out our best selves.
