CAPE Represented GIS Employees at Assessor's Office Win 'Out-of-Class' Pay Victory

Sixteen CAPE-represented Assessor Survey Mapping Techs—SMT's requested either a promotion or Out-of-Class (OOC) Bonus in June of last year for performing GIS Tech work without proper compensation. CAPE represented the professional employees in a grievance that was partially granted in December 2015, promoting 9 and granting the Out-of-Class Bonus to 7 SMTs. Retroactivity was granted but 1 month short of the requested remedy to June 12, 2015.



However, there are now 9 new GIS Techs, in addition to the seven already receiving the OOC Bonus after CAPE intervened and facilitated 16 grievances.

Those now receiving the OOC Bonus were subsequently informed that each of them will be required to pass an open competitive exam

to be promoted. The members were also informed that if they decided not to take the open competitive exam, the would be required to repeat the OOC process to continue receiving the OOC Bonus pay.

Unfortunately, three CAPE activists who were leading the effort to file the grievance, and had trained SMTs in their GIS duties, were unilaterally excluded from promotion after the exam. There is concern among many involved that the Assessor's Office managers will continue their resistance to promoting these CAPE grievance leaders.

Many question the "open competitive" status of the next exam which allows the Assessor's Office managers to promote from a much larger list, possibly leading to favoritism at the expense of the highly competent employees who are leading the effort to make sure promotions and bonuses are conducted fairly and in accordance with the MOU. A much better GIS promotional process would restrict the exam to Assessor's Office employees. Only Assessor's Office employees have been subjected to this treatment. Every other department, including the Department of Public Works, has handled the GIS transitional process efficiently and fairly.

CAPE-represented SMT ranks are growing! Last year's multi-department job title reclassifications led to many shifts in bargaining unit representation, especially for GIS employees. The process is now complete and CAPE is pleased to report that all formerly CAPE-represented SMTs have been accreted back into CAPE, along with several higher level SMT/GIS classifications previously represented by SEIU.

Mosley and her coworkers were understandably concerned about securing an adequate, safe workspace at the new location. At the request of CAPE, Mosely, Telecom Services Engineer Steve Tran and CAPE representatives met with ISD Management to discuss the some obvious issues related to the Eastern Avenue site.

Good faith efforts by CAPE and ISD Management minimized the impact of the most troubling aspects of the move. For CAPE-represented ISD employees, the overall results following the discussions with management are mixed.

Although most would agree that ISD management has made an attempt to address the concerns raised by CAPE representatives, some ISD employees are still unsatisfied with the efforts by ISD management to fully address the concerns.

CAPE members cast their ballots for the 2016-17 Board of Directors elections. Seven candidates ran for 4 Board positions. Nearly 400 members returned ballots.

All of the incumbent Board members were re-elected to the Board of Directors

CAPE Members Mourn Loss of Board Member Brent Decker



With tremendous sorrow, we announce the passing of one of CAPE's strongest organizers, CAPE Director Brent Decker. Brent died on Thursday, September 22, from injuries sustained in an automobile accident on September 4, 2016.

Brent's service with the Office of the Assessor began in 1989 as an Appraiser Trainee. His first assignment was at the former Pasadena regional office, where his abilities and strong work ethic caught the eye of Assessor management. After subsequent assignments in other regional offices and Major Real Properties, Brent was sent to the Assessment Appeals (AAB) section, where he volunteered as an Assessor's Representative, a position that represents the Assessor and its appraisers at the Assessment Appeals Board. At this time, the AAB section was undergoing restructuring, but, as always, Brent stepped up and helped work to bring about lasting changes. Prior to returning to a regional supervision assignment, Brent's expertise and professionalism were again noticed by management, and he was sent to the Training section, where he oversaw the education of new classes of Appraiser Trainees. As a 13 year member of the International Association of Assessing Officers (IAAO), a professional organization for those employed in the assessment field, Brent was always actively involved in promoting the continuing education and advancement of the appraisal profession, and it showed in every assignment he undertook. Brent dedicated 28 years to his career with the Assessor's Office.

As a CAPE volunteer, Brent tirelessly pursued equity for all of his fellow employees. He was a CAPE member for 24 years, and in that time, he volunteered to serve on numerous committees and salary contract negotiations on behalf of Appraiser and Supervisory Appraiser units. Brent's desire was to see management treat employees fairly and professionally. He was elected to the CAPE Board of Directors in 2014, as he wanted to take a more active role in serving CAPE and making this union even stronger. Along the political front, Brent was also guite active in Democratic politics, a role that goes hand in hand with union advocacy. He had run for State Assembly at one point, coming in second, but still determined to make a difference.

Outside of his professional life, Brent was an excellent musician and an avid USC fan. During his military service in the United States Air Force, he played brass in the 562nd Air Force Band. When he attended USC, his enthusiasm and talent for marching bands made it the natural choice to join the USC Trojan Marching Band. Music was very important to Brent, and he was still actively playing with local big bands on a regular basis, so much so that one of his bands had recently went into the studio and recorded some demo projects. As usual for Brent, he wanted to pass on his passion and expertise to less experienced musicians and was working with local community college students to help them achieve their own goals and dreams.

Appraiser Field Trainer ARB Victory

In a move typical of Assessor's Office managers, the Field Trainers for Class #73 were shorted pay for their Additional Responsibilities Bonus (ARB) for the final days of their Supervisory work done on behalf of the Class.

CAPE representatives were notified and subsequently addressed this issue as a Paycheck Error and requested a correction in the form of payment of the ARB for that period. Also typical of Assessor's Office managers, the correction took nearly 8 months to complete.

CAPE representatives are pleased to announce that the Field Trainers did finally receive the ARB to which they are contractually entitled for supervising their trainees through certification and beyond.

Field Trainers familiar with the workload describe the intense supervisory work as "supervision on steroids". Although this may not be a big monetary issue, it is a very important matter of compliance with the terms of the Appraiser MOU. It demanded persistence and patience from CAPE and our Field Trainers for the Assessor to understand and appreciate the nature of the work of Appraiser Field Trainers too fully support our claim.

CAPE representatives persisted in making sure the Trainers' rights under the terms of the MOU were fully enforced. In the end, this victory validated the fact that the Additional Responsibilities Bonus is well earned by Appraiser Field Trainers for the service they provide to the Department. It also demonstrates the value of a Union Contract and its enforcement by CAPE, beginning with CAPE members asserting their rights.


