



NOMINATING PETITION

We, the undersigned, desire to nominate _____ as a candidate in the 2019 Election of the Board of Directors for the California Association of Professional Employees.

Of the nine positions on the Board, six (6) Board seats are to be filled. Five (5) are for two-year terms. One (1) is for a one-year term. The five (5) candidates receiving the largest number of votes will be elected to two-year terms (September 2019-September 2021). The candidate with the sixth largest number of votes will fill the unexpired one-year of the term (September 2019-September 2020). The election of the Board of Directors will be completed by August 22, 2019. The official election results will be posted on CAPE Bulletin Boards at all feasible County worksites.

Nominating Petitions, to be valid, must be signed by at least twenty (20) CAPE MEMBERS in good standing (not including the nominee), and received by the Union **NO LATER THAN 5:00 P.M. ON THURSDAY, JULY 11, 2019.** Before a nominee's name will be entered on the Official Ballot, the authorization below must be completed and signed by the applicant indicating his/her willingness to serve if elected.

Along with this petition and authorization, nominees are invited to submit a Candidate Statement of **not more than 250 words** containing information as to the offices he/she may have held in CAPE, participation in CAPE activities and other information which may be of interest to CAPE members for election purposes. Candidate Statements must also be received **no later than 5:00 p.m. on Thursday, July 11, 2019.** Candidate Statements will be reprinted as submitted, up to 250 words, and will accompany each ballot.
