## **MOU LANGUAGE FOR LICENSE BONUS**

Employees in Bargaining Units 501, 502, 511, and 512 will receive additional compensation as specified below if they meet the criteria specified below for each of the applicable licenses and/or certifications:

#### Structural Engineer License

501: Effective April 1, 2007, any Associate Civil Engineer or Civil Engineer in the Unit\_who is licensed as a Structural Engineer from the State of California and who is\_assigned by management to duties requiring the knowledge and skill which are\_both certified and characterized by licensure as a Structural Engineer, will be\_paid a 5.5% bonus.

502: Effective April 1, 2007, any Senior Civil Engineer in the Unit who is licensed as a Structural Engineer from the State of California, and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Structural Engineer, will be paid a 5.5% bonus.

#### Land Surveyor License

501: Effective April 1, 2007, any Associate Civil Engineer or Civil Engineer who holds a valid license as a Land Surveyor, and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Land Surveyor, will be paid a 5.5% Land Surveyor License Bonus.

502: Effective April 1, 2007, any Senior Civil Engineer in the Unit who holds a valid license as a Land Surveyor, and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Land Surveyor, will be paid a 5.5% Land Surveyor License Bonus.

511: Effective April 1, 2007, any Principal Survey Mapping-Technician in the Unit who holds a valid license as a Land Surveyor. and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Land Surveyor, will be paid a 5.5% Land Surveyor License Bonus.

512: Effective April 1, 2007, any Supervising Cadastral Engineer I, II, III, or Supervising Survey-Mapping Technician in the Unit who holds a valid license as a Land Surveyor, and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Land Surveyor, will be paid a 5.5% Land Surveyor License Bonus.

#### Traffic Engineer License

501: Effective April 1, 2007, any Civil Engineer Assistant, Senior Civil Engineering Assistant or Principal Civil Engineer Assistant, who holds a State of California Traffic Engineer license and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Traffic Engineer, will be paid a 2.75% Traffic Engineer License Bonus.

502: Effective April 1, 2007, any Supervising Civil Engineering Assistant in the Unit who holds a State of California Traffic Engineer license and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Traffic Engineer, will be paid a 2.75% Traffic Engineer License Bonus.

511: Effective April 1, 2007, any Highway Engineering Specialist in the Unit who holds a State of California Traffic Engineer license, and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Traffic Engineer, will be paid a 2.75% Traffic Engineer License Bonus.

512: Effective April 1, 2007, any Supervising Highway Engineering Specialist I or II in the Unit who holds a State of California Traffic Engineer license, and who is assigned by management to duties requiring the knowledge and skill which are both certified and characterized by licensure as a Traffic Engineer, will be paid a 2.75% Traffic Engineer License Bonus.

A copy of the employee's valid California Structural Engineer, Land Surveyor, or Traffic Engineer License must be attached to the request form when submitting for approval or the request will be returned to the employee unprocessed.

#### **Geotechnical License Bonus**

501, 502: Effective March 1, 2019, any permanent full time Associate Civil Engineer, Civil Engineer, and Senior Civil Engineer who is assigned to Geotech Division by management duties requiring the knowledge and skill characterized by the license shall receive a 5.5% monthly bonus.

### Registration/License Bonus

501, 502: Effective March 1, 2019, any permanent full time employee in a classification not requiring registration or license who attains a registration or license required in a higher classification in the classification series is eligible to receive a monthly bonus of \$250 until such time as the employee is promoted to the classification that requires the employees registration or license, not to exceed eighteen (18) months from the date of registration or license.
